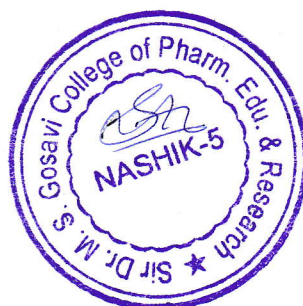



- Each of the above is a criminal offence.

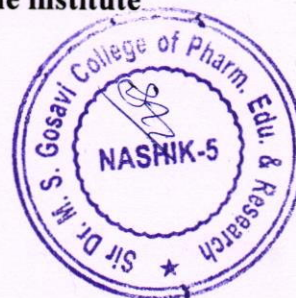
**A Student indulging in ragging can be :**

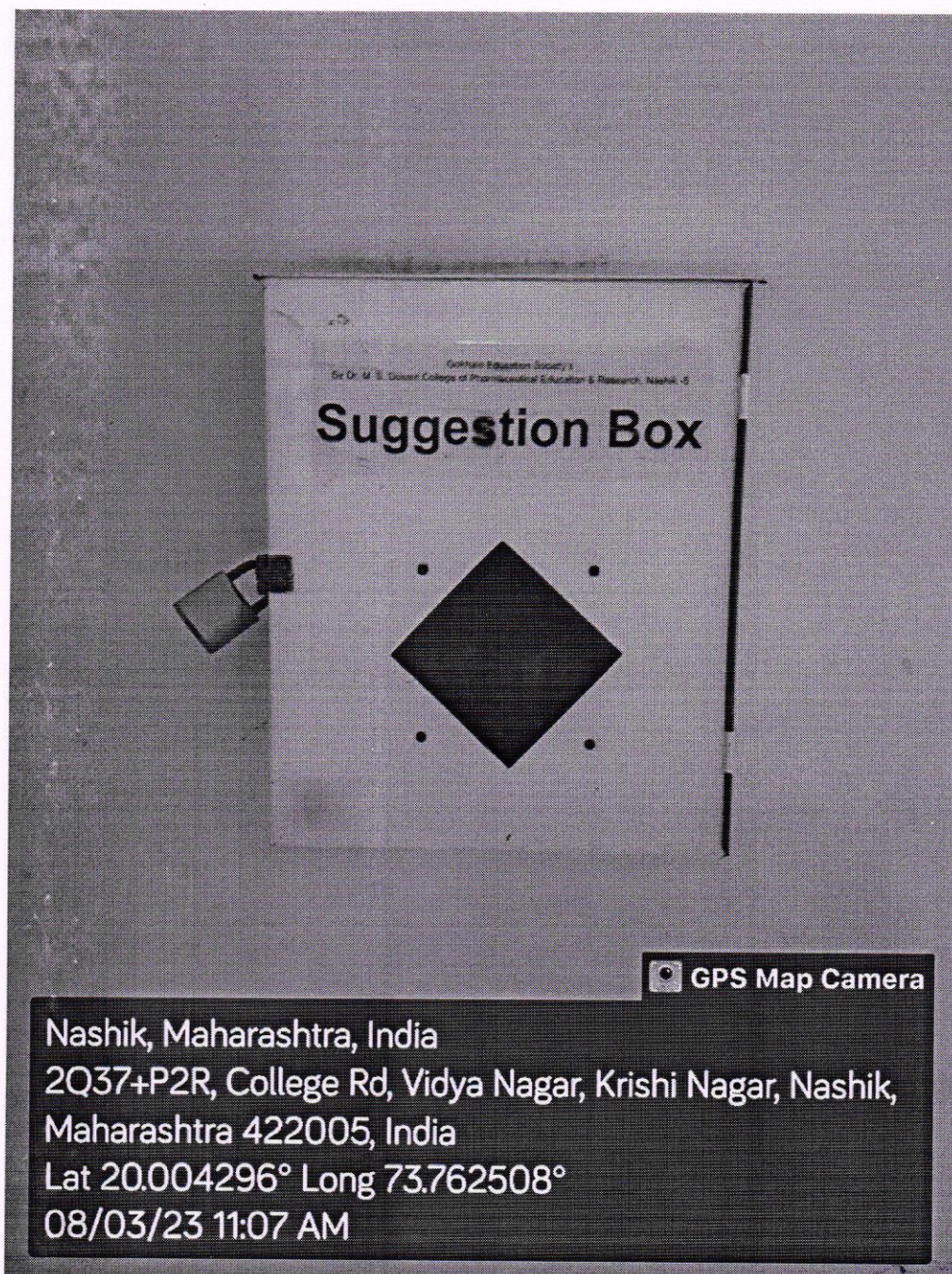




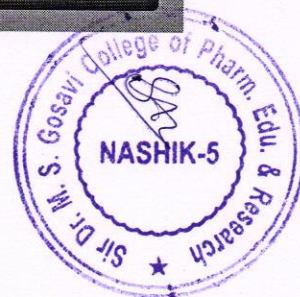
**Display of Emergency Number in the Institute**



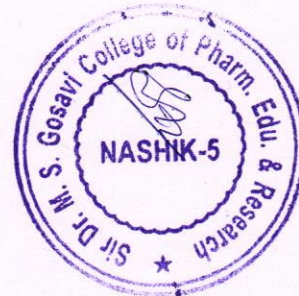
