Both of the faculty members and research students are committed to upholding standards of justice and integrity in their academic endeavours. The College works to create and maintain a vibrant research environment by:

- Create a favorable atmosphere by supporting and facilitating research activity.
- Promote a climate that is open to science and an aptitude for research.
- Promote academic-industry collaboration through joint research consulting.
- Establish a forum for sharing research findings.
- Encourage resource mobilization and capacity growth to enable high-caliber research.
- Adhere to high standards of ethics in the input, processing, and dissemination of research. Guidelines for Promoting Research Activities, Joint Projects, and Collaboration

Consulting initiatives within academic institutions, businesses, and departments.

1. The faculty and students should participate in research activities to improve their technical skills and knowledge.
2. The faculty should undertake joint collaborative projects and consultancy activities in their expertise.
3. The faculty should establish network with college / industries for identification of potential partners for collaborative research
4. In such cases (collaborative work) the college should preferentially sign the Memorandum of Undertaking (MOU) or agreement which clearly states the terms and condition to carry out the work.
5. In case of consultancy activities, the work can be allotted to Departments/ Investigators pertaining to the required area of expertise.
6. The faculty should be encouraged to function as guides and co-guide for monitoring research activities.
7. Ethical practices should be followed during the conduct of animal experimentations as per the guidelines of CPCSEA and OECD.
8. Each faculty member guiding M. Pharm students for their dissertation work must publish a minimum of one research paper in National/International journals of repute.

9. In case of faculty guiding PhD students the guides should ensure that each student should publish a minimum of two research papers in cited National / International journals.
10. The faculty should be encouraged to undertake research projects with emphasis on interdisciplinary / multi-disciplinary approach.
11. The research committee should make provisions for conduct of workshops / conference / training sessions to supplement the academic and research activities. Faculty should also participate and present their research findings in various National / International workshops / conferences.
12. The research output, in case patentable, the College will provide necessary assistance in filing IP.
13. Efforts must be taken to develop the scientific temperament and inculcate research culture and aptitude among the students
14. For projects sanctioned through SPPU, Pune an Academic and Research coordinator (ARC) is appointed to ensure smooth implementation of project. The Principal Investigator (PI) / Co-investigator are required to submit their requirement for sanction / purchases to be made (Laboratory chemicals / consumables / instruments etc.) to the institutional stores. The colleges also provide autonomy to the principal investigators for utilizing contingency amount for procurement of suitable items for carrying out the research work. The ARC should co-ordinate with various bodies for timely release for grants to imitate and run the project. The PI/ Co-investigator should submit the report of the work done with audited statement of the expenditure at timely intervals as required by sanctioning body. On completion of the research project the PI / Co-investigator should submit the final report of work completed with utilization certificate to the funding authorities.
