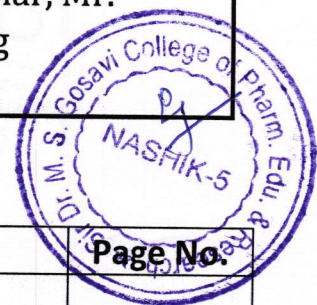

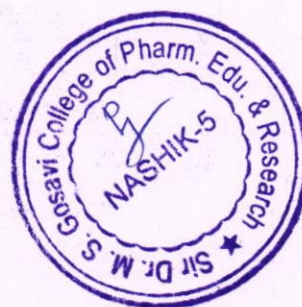



In response to Society's advertisement dated 14th February 2013 you had applied for the post of Principal. You were interviewed for the above post by the University Selection Committee appointed by the Management under Statute No. 415 of the University of Poona.


This is to inform you that as recommended by the University Selection Committee the Management has appointed you on the said post, on the basic pay of Rs. 37,400/- in the scale of Rs. 37,400-67,000 with AGP of Rs. 10000/- as per rules in Gokhale Education Society's Sir Dr. M.S.Gosavi College of Pharmaceutical Education & Research, Nashik - 422 005 (Non Grant-in-aid) with effect from 14th August 2013 on probation for two academic years subject to the following terms and conditions.

1. This post is reserved for Open category. Since you belong to the said category, you are appointed on **probation** for a period of two academic years from the date of joining.
2. The pay and allowances for the appointment shall be the pay & allowances prescribed, approved and sanctioned by the Government for the concerned post and the said pay & allowances as per Government sanction shall be paid only after approval of your appointment by the competent authority for the post.
3. Your services will be governed by Maharashtra University Act 1994, statutes code of conduct, ordinance and rules and regulations laid down by the University of Pune, State Government, AICTE and the Society from time to time.
4. Initially you are appointed on probation for a period of two academic years from the date of joining and the same will depend upon the number of students enrolled and work-load available during the tenure;
5. Since you are appointed for a period of more than one year, you shall earn annual increment, subject to satisfactory report of your work by the Head of Department/ Institution. Kindly note that the appointment and salary shall be subject to approval by the University Authorities.
6. Your appointment during each of the term of the year during your tenure, is subject to the minimum number of students and the work load prescribed for the post.
7. You will have to submit the originals as well as certified true copies of relevant testimonials such as Birth Date certificates, marksheets experience certificate, discharge/relieving certificate, last pay certificate, Caste Certificate, change of name certificate (if any) before joining your duties.
8. In case you accept the appointment you shall have to execute the deed of contract of service as prescribed in the statutes at the time of joining the duties.




9. You will be allowed to join the duties on production of following documents :
 - Two pass port size photographs
 - Character Certificate from two eminent persons, one of whom shall be a gazetted officer appointed by Government.
 - Discharge Certificate from previous employer (if any)
10. You shall undergo medical examination by the approved Medical Officer or by the Civil Surgeon at the place of your duty, within three months from the date of joining the duties. The appointment shall be provisional and conditional, pending submission of Medical Certificate stating that you are free from any contagious disease and that you are physically fit for the employment on the staff of the College/ Institution.
11. You are required to give the correct mailing address as soon as you join the duties and any change in the address given earlier shall be communicated to the Principal and the Society. It will be presumed that any letter sent by Registered post A.D. on the address given, shall be deemed to have been acknowledged duly signed by you.
12. You will not engage your self or in the name of your spouse in any private tuitions or private coaching classes and that you will give an undertaking to that effect at the beginning of each year.
13. You will not engage your self in any other job paid/ full time/ part time or otherwise, during the continuance of your service without the specific written permission of the Society/ competent authority/ Management.
14. Your services are transferable to any other Colleges/ Institution run by the Management.
15. Your appointment is liable to be terminated/ discontinued by either side/ party, by giving one months notice or one month's pay in lieu of notice period during service tenure as probationer.
16. If you are found absent continuously for more than thirty days without permission, your service will stand terminated automatically. If you are found guilty of violation of any terms and conditions mentioned above you will be liable for disciplinary action. The punishment should be as decided by the management as provided for in the statutes. During the period of your service you shall not directly or indirectly do any such thing which is subversive to the interest of the Society/ University/ Institute/ College/ students.
17. You will have to stay in the premises provided for the Head in the Campus of the Institution from the date of your joining.
18. You have to communicate your acceptance to the Management/ College/ Institution within seven days from the date of receipt of this order failing which your appointment order shall stand withdrawn and liable to be cancelled.

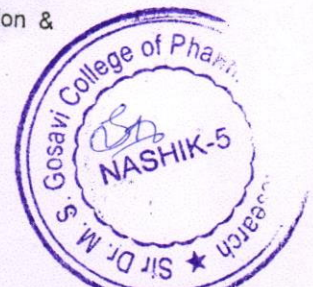
