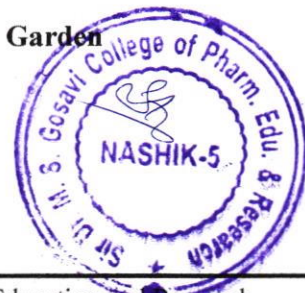

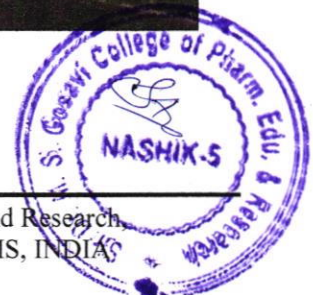

V) NSS Special Winter Camp Activities (Dec. 24 to 30, 2019)

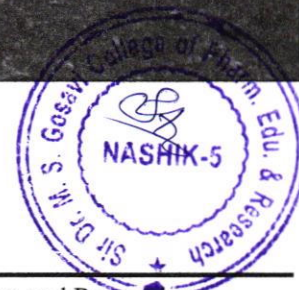

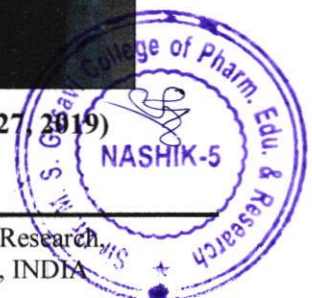

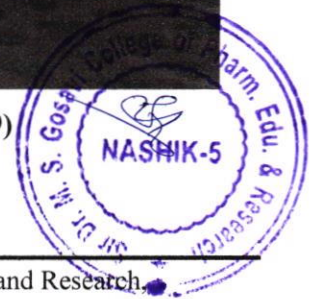
